I, have the honour to state that, on 4th May, 2023 at around 11:30 AM some Meitei miscreants belonging to Meltel Leepun and ArangbamTenggol who had been carrying sophisticated weapons like AK riffes, 303 riffes. Pistol, Motor etc. with vehicles forcefully entered in my village located at KungchupChingkhong, Kangpokpi District. They looted all valuables and set ablaze to ashes. The approximate value of lost and destroyed are to be about Rs.87,11,000/ (Rupees Eighty seven lakh) only.
