I have the honour to report you that on the intervening night of 03/05/2023 and 04/05/2023, the large numbers of Kukis With Knife and weapons broke into my House and completely burn down as well as destroy my house and properties, also looted my properties as much as they can ,my house is located at Charhajare near Sanatan Sanskrit Vidyalaya,

The properties that were burn down and looted are:

1. Puccka House totally burn down: -Rs 40,00,000/- (appx)

 Furnitures (1 Double Bed,3 Medium size Bed, 4 Godrej,1 Alimarah,Show Box, 1 Dressing table, 2 Fiyankok, 3 Side Table,1 Sofa set, 1 Dining Table, 1 iron rack,

3. Clothing:

- Rs, 2,50,000

4. Kitchen Items:

- Rs 3,00,000

5. Jewellery:

-Rs 4,00,000

6. Pleasure two wheeler:

- Rs 80,000

7. Electronic items : - (1 Television, 1LED TV ,1 Solar wih bettery , 1 Dist tv, 2 Fan , 2 Mobile.:

- Rs 1,10,000/-

Total:- 56,10,000

I made this report to your good – office ,as present prevailing situation, it is not accesible to my jurisdiction to report the same at P.S.-Sapormeina Saitu Gamphazol Kangpokpi District. I also can't make this report in time , because I and my family were not in condition to report the unfortunate incident. On the day incident occurred on dated night of 03/05/2023 and 04/05/2023 my family was rescued by Motbung Assam Rifle personel and gave them shelter till 05/05/2023 and shifted to Sekmai police Station in evening of 05/05/2023.

Therfore my family was taken to relief camp and handed over to our relatives. The situation was so harsh that the emotional distress of losing entire properties and leaving the birth place was so paintful, and tough and not manageable immediately and I also came to leave from my duty place Gujarat on 08/05/2023. Therefore I could't make the report timely.

I therefore request to you Sir to take up necessary legal action against the large numbers of Kukis who burn down m house and looted my properties
