

These criminals broke open my gate(s), destroyed and looted every valuable property from my "Owned/Rental" house, and premises worth Rupees 27,12,000 lakhs (approx) and they burnt down all the remaining things.

Therefore, with utmost respect, I request you to take strong action against the perpetrators by registering under relevant sections of the Indian Penal Code.
