My house and properties which is located at Kangchup Songlung, Kangpokpi district have been vandalized and all properties including important personal file and documents have been looted and destroyed as well as threathening of life ,attempted murder by using machete and physically assaulted by the majority Meitei/Meetei community consisting of Arambai Tenggol, Meitei Leepun, Kangleipak Kanba Lup. The approximate value of lost destroyed and looted properties is estimated to be about Rs 75 Lakhs.

As the law and order situation is not good in the area, I could not complaint in my respective police station as well in time.

The following items of land and properties were destroyed and looted are as follows:

- 2). Jewellery and Clothing Items.
- 3). Construction Materials.
- 4). Others Movable and Immovable Assets.
