
My chicken farm house and including chicken farm properties with the capacity to rearing 2000 Chicken's have been vandalized and all the chicken that have been rearing at the time of incidents numbering of 2000 chicken's including its feeds are looted, destroyed and burned as well as threatening of my own personal life ,attempted murder by using machete and physically assaulted by the majority Meitei/Meetei community consisting of Arambai Tenggol, Meitei Leepun, Kangleipak Kanba Lup. The approximate value of lost destroyed and looted properties is estimated to be about Rs. 15 Lakhs.

As the law and order situation is not good in the area. I could not complaint in my respective police station as well in time.

I therefore kindly request you to take necessary action in this regards. Thanking You.
