With due respect and humble submission, I, Chinneimoi Touthang, 23 Years d/o Semngam Touthang, House No.40 of Kangchup Songlung Village, Kangpokpi District would like to file a complaint against on properties and Piggery farm house damaged on the 5<sup>th</sup> June, 2023.

My piggery farm house and including piggery farm properties which is taken under the loan account no.41401122951 of State Bank of India(SBI) Kangchup Branch in the loan amount of 4 Lakhs including 15 nos. of piglets, located at Kangchup Songlung Village, Kangpokpi district have been vandalized and all the piglets and it's feeds, that have been rearing are looted, destroyed and burned as well as threatening of my own personal life, attempted murder by using machete and physically assaulted by the majority Meitei/Meetei community consisting of Arambai Tenggol, Meitei Leepun, Kangleipak Kanba Lup.

As the law and order situation is not good in the area. I could not complaint in my respective police station as well in time.

I therefore kindly request you to take necessary action in this regards. Thanking You.
