



I am to bring to your notice that on the 5<sup>th</sup> June 2023, at 11 am to 12: 00 am, my residence(owned/Rented) at Kangchup Songlung, PS Gamnom Sapormaina, District Kangpokpi Manipur was attacked, destroyed looted and burned by a group of Meetei/Meiteis.

These criminals broke open my gate(s), destroyed and looted every valuable property from my "Owned/Rental" house, and premises worth Rupees 26 lakhs (approx) and they burnt down all the remaining things.

Therefore, with utmost respect, I request you to take strong action against the perpetrators by registering under relevant sections of the Indian Penal Code.
