



Subject:- Report on vandalism, looting of properties and burning on down of house at Kangchup Songlung, P.O Lamsang & PS Sapormeina & District -Kangpokpi on 05-06-2023 at around 7:00 am also for shooting me with a bullet on my left back (below Scapula) by Meetei/Meitei's goons suspected to be members of the ArambaiTengol and MeeiteiLeepun along with a mob of meetei/Meitei on 28-05-2023

Sir,

With due respect, I the undersigned would like to make a report to your good office about vandalism, looting of properties and burning down of house at KangchupSonglung, P.O- Lamsang & P.S- Sapormeina & District- Kangpokpi on 05-06-2023 at around 7:00 am by Meeitei/Meitei's goons suspected to be members of the ArambaiTengol and MeeiteiLeepun along with a mob of Meetei/ Meitei.

At the very outset, I would like to draw fewline for your information that due to the present situation of ethnic class between Tribal and Valley base Meitei/Meeitei from 03-05-2023. That due to ethnic class the said members of the ArambaiTengol and MeeiteiLeepun never stop vandalism, looting and burning down of tribal properties from their rented resident or from their resident in the valley areas till today. On 05-06-2023 the door of my house was destroyed by Meeitei/Meitei's goons suspected to be members of the ArambaiTengol and MeeiteiLeepun and vandalized, looted all my properties and burnt down my house, all of my properties would worth Rs.20,00,000/- (Rupees Twenty lakh). It may be noted that on 28-05-2023 around 12:00 noon I have run out from my resident with my other family members for the safety of our life as the saidmemberofArambaiTengoland MeeiteiLeepun along with a mob of Meetei/ Meitei have come to attacked us at our compoung as we are tribal and on the said day while we were ruing for our life, I was shoot by a bullet on my left back (below Scapula) which cause me Projectle injury and could not reach my native place which unable me to make the report on time. I do further request you to include in my report of the said bullet injury of mine for the said action of the above members with an intension to kill me as I am tribal. Presently I am taking medical treatment for the said bullet injury.

It is requested to your good office to make entry of my report a Zero F.I.R and take action against the perpetrator and the members who shoot me as per Law and also issue me the copy of the said report for my reference in future
