P.O Lamsang & PS Sapormeina& District -Kangpokpi on 05-06-2023 at around 7:00 am

Sir,

With due respect, I the undersigned would like to make a report to your good office about vandalism, looting of properties and burning down of house at KangchupSonglung, P.O- Lamsang& P.S- Sapormeina& District- Kangpokpi on 05-06-2023 at around 7:00 am by Meeitei/Meitei's goons suspected to be members of the Arambai Tengol and Meeitei Leepun along with a mob of Meetei/ Meitei.

At the very outset, I would like to draw fewline for your information that due to the present situation of ethnic class between Tribal and Valley base Meitei/Meeitei from 03-05-2023. That due to ethnic class the said members of the Arambai Tengol and Meeitei Leepun never stop vandalism, looting and burning down of tribal properties from their rented resident or from their resident in the valley areas till today. On 05-06-2023 at around 7 am in the morning my gate was destroyed by Meeitei/Meitei's goons suspected to be members of the ArambaiTengol and MeeiteiLeepun and they vandalized, looted and burnt down my house, all of my properties worth Rs.65,00,000/-(Rupees Sixty Fivety lakh). on the said day I along with other families members were attacked by the above mention members because we are tribal and no life of a tribal will be spare were the words used by them at the time coming inside at our compound.We have to run for our life and I could not make the said report on time because I could reach my native place from Imphal as I am traveling from on state to another to reach my native place.

It is requested to your good office to make entry of my report a Zero F.I.R and take action against the perpetrator and the members who shoot me as per Law and also issue me the copy of the said report for my reference in future.The list of my properties of which I could remember were attached here along with my report.


