Sir,

I have the honour to state that on 30/01/2023 at about 10:30 pm, a selected combined team of Kangpokpi District Police comprising teams of OC/GSPM-PS, OC/KPI-PS and DSP-GSPM led Addl. SP (Ops)/KPI have conducted random frisking and checking at Thingbongjang village market shed (Corona Bazar) on NH-2 under the overall supervision of SP/Kangpokpi. During which, the combined teams stopped one Tata Truck bearing registration no. NL 01-AC-5936 (12 wheels) proceeding towards Kangpokpi and on verification of the driver and handyman at the spot, identified themselves as Salam Devan Singh, 38 years S/o (L) Salam Tomba Singh of Keibul Lamjao Forest Mamang, PO/PS-Moirang, Bishnupur District, Manipur (Driver) and one occupant namely Ningombam Chenish (28) yrs S/o Ibohan of Bashikhong Mamang Leikai, PS-Irilbung, Imphal-East, Manipur. On preliminary questioning of the driver, he was found in suspicious manner. He was tactfully questioned and finally admitted to have possess contraband items concealed inside his vehicle. On confirming the presence of contraband drugs in the vehicle, no further checking was done in order to observe formalities at the spot. However, due to vulnerability of the situation (odd hour) and also unable to contact executive Magistrate, the detained Truck along with the detained driver and the occupant were taken to GSPM-PS for safe custody.

On being informed, the Executive Magistrate SDO/SDM Saitu Gamphazol had arrived at GSPM-PS on the next day, i.e date 31/01/2023 at 10:30 am for witnessing necessary procedures. In the presence of the said Executive Magistrate and two civil independent witnesses (TSA-SH), the detained driver has taken out the concealed drugs (i.e Soap cases containing suspected to be contraband drug Heroin No. 4) which were neatly stacked inside one wooden speaker box and inside front cabin box. On production by the detained driver, the recovered soap cases were marked 1, 2, 3,.....till 54. Out of the total 54 (fifty-four) soap cases, 27(Twenty-seven) soap cases were put together in one transparent polythene bag and marked as Lot-1 for identification. Similarly, the remaining 27(Twenty-seven) soap cases which were marked 28-54 were again put together in another transparent polythene bag and marked as Lot-2. The two Lots i.e Lot-1 & Lot-2 were weighed by using weighing machine in the presence of executive magistrate, independent witnesses, detained persons and found 1.155 kgs and 1.160 kgs respectively including the weight of the plastic soap cases and polythene bags. And the combined weight of Lot-1 & Lot-2 was weighed and found weighing 2.315 kgs including the weight of plastic soap cases and polythene bags.

The recovered 2.315 kgs of soap cases suspected to be containing contraband drugs (Heroin No. 4) and other items were seized in presence of Executive Magistrate, Independent witnesses and detained persons at 11:15 am by preparing a formal seizure memo and also obtained their signatures. The detained persons were formally arrested at 11:25 am by observing formalities.

Following the order passed by the Hon'ble Spl Judge ND & PS Manipur vide No. SPL-C/ND & PS/2019/659-663 dated 26/11/2019 corresponding Cril. Appeal No.652 of 2012 (MANU/SC/0073/2016:2016) 3 SC & 379) the necessary proceedings laid under ND & PS Act will be observed before the Hon'ble Court of JMFC, Kangpokpi.

Therefore, the two detained individuals and seized items are handed over to you for taking

further necessary legal please.
