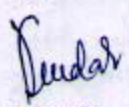

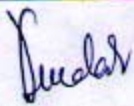

Sir,

With due respect, I would like to report you that I am a resident of Phongakchao Dhal Mayai, Leikai, Bishnupur. On 3/5/2023 at ① 5:30 pm, while I was staying at my house, some unknown group suspected to be Kuki miscreants started vandalising and burning down my house. On that my body was caught by fire and household properties were also stolen away. I was evacuated to hospital and undergone medical treatment for about 4 months and 40% of the body was injured due to burning. I along with my family members were displaced since the eruption of ethnic clash i.e. on 3/5/2023 till date and now taking shelter at Shanthong Community Relief camp. I could not report well in time due to displacement and undergoing medical treatment.

Therefore, I request you to kindly take up necessary legal action against the miscreants at the earliest.
