



I, the undersigned have the honour to state that large numbers of innumerable unidentified group of people belonging to Kuki Community with deadly weapons and sophisticated arms including Kuki Militants groups stormed to all Meitei inhabited areas of Motbung Meitei Leikai near Motbung Bazar on 3rd May 2023 at @ 8.00 pm. The said unidentified groups vandalized/burnt down my house and shop including Hyundai Venue B/Regd No. MN04P2363 located at Motbung Meitei Leikai near Motbung Bazar and looted all valuable items, property and also lost some documents. In that unfortunate incident, I have lost a total amount of Rs. 1.5 crores Approx. After the said unfortunate violent, I along with my family members have left our village and taking shelter at our relative house located at Kakching Laithagol Leikai.

It is therefore, prayed that the respected Sir may kindly initiate and take necessary legal action (s) against the accused persons and the persons involved in the said inhuman acts and heinous crime committed by the accused persons and the persons involved as per law of the land as early as possible.

I shall be grateful for your kind co-operation and necessary actions(s).
