

I have the honour to report that on 29/05/2023 at around 03:00 pm some Kuki unknown persons numbering about 40/50 attacked with deadly weapons in our house registered in the name of Akham Rahul Singh (36) S/o Late A. Shyamananda Singh at Leimakhong Bazar while taking the chance of the absence of our family members. As a result the said unknown persons had stolen iron bars used in the construction Cement and other valuable items respectively. The total cost of the value is rupees 5 lakhs (approximately).
