



I have the honour to state that it was reported on 4th May, 2023 at around 8 am by my JCB driver namely Laishram Inaobi that in the night of 3rd May, 2023, my JCB bearing Regn. No. AR05-4438 having E/No. I031701514 & Ch/No. HAR3DXSUV01501181 has been set on fire by mob at Keikot Turel under Sapermeina-PS of Kangpokpi District. I could not report to the jurisdictional Sapermeina Police Station because of the volatile situation of the communal violence between Meiteis and Kukis. As such I am reporting to lodge an FIR for the arson of my JCB at Kangpokpi.

It is therefore, requested to take up legal action against those unknown persons who committed the crime.


