Sir

I have the honour to report that on 29/05/2023 at around 03:00 pm some Kuki unknown persons numbering about 40/50 were attacked with deadly weapons in our house registered in the name of Ningthoujam Ibemcha Devi (47) and Ningthoujam Karuna Devi C/o Chaoba Singh located at Leimakhong Bazar while taking the chance of the absence of our family members. The said unknown persons vandalised/burnt down all our property inside our house, Shop and stolen jewellery, all our children's educational books, flat screen TV, Refrigerator, washing machine, Laptop, Utensils and all the Furniture respectively. The total cost of the value is rupees 60 lakhs (approximately).

It is therefore, requested kindly to take up necessary legal action against the said unknown persons as per the law of the land.


