

Sir,

With due respect, I would like to report that I am the Proprietor of the Factory namely M/s IntextDecora situated at KhuraiAhongeiLeikai, PO -Lamlong, PS -Porompat and GSTIN - 14BJNPS2576N2ZE. A branch of the factory was opened at Charhajare, P.O. - Motbung, PS -G. Saparmeina PS, Kangpokpi District at a land taken on Lease for 10(Ten) years owned by, Charhajare, P.O. - Motbung. As reported by the Chairman of the SanatanGorkhaSanskaraGhat, all the Structures and assets of the factory were burnt down to ashes by unknown armed Kuki miscreants on 6th May, 2023 at about 6:00 pm in the incidents of arson and violence between the two communities in Manipur since 3rd May, 2023.
