Subject : Report on damaged/arson/looted properties by the unknown armed/unarmed miscreant

Sir,

With due respect, I, the undersigned would like to lay the following few lines for your kind consideration and necessary action.

Taht, I am a businessman and residing along with my family at Leimakhong Ex-Servicemen Colony since the last 23 years back and running a shop of Mobile Phone accessory cum Mobile repairing named "Mison Mobile" at Laimakhong Bazar. Unfortunately, a communal violence between the Meitei and Kuki community swept our state that started from May 03/05/2023 leading to a grave loss of life and widespread destruction of personal and public property. Entire village including homes and places of worship were burnt and razed to the ground. Thousands of persons were force to flee their homes and villages and are now displaced. Due to panic and fear, I along with my family members have been shifted to my native village i.e. Kongkham Makha.

That, on 13/06/2023 at about 6:00 pm, it is learnt that some unknown armed/unarmed Kuki Militants had damaged/arson/looted the properties of my shop on 29/05/2023 at around 3:45 pm. The details of the damaged/arson/looted properties are enclosed in a separate sheet as ANNEXURE "A".

It is, therefore, requested you to kindly take up necessary legal action against the unknown armed Kuki Militants at the earliest.




