




Subject :- Report.

Sir,

I have the honour to state that on 04-05-2023 around 6:30 am. I and my family left my dwelling house, located at Leimakhong Bazar near SBI Bank and ran for our lives due to suddenly attacked by sophisticated armed unknow Kuki miscreants and had destroyed my house and also looted away all my household items including gold ornaments, ready cash, traditional dress and rice bags worth to the value of Rs.35,82,700 (Thirty-five Lakhs Eighty Two Thousand Seven Hundred only) and in addition to that they have looted my electronic shop under name and style Kishan mobile, situated near my house and have looted all the electronic items form my shop worth to the value of Rs. 44,24,200 (FortyFour Lakhs Twenty four thousand and two hundred only) and they have further looted the store room attached in my dwelling house where i kept some of the electronic items worth Rs. 4,57,950 (Four Lakhs Fifty Seven Thousand Nine Hundred and Fifty). The Total value of the looted and destroyed items is worth to be value of Rs. 84,64,850 (Eighty four Lakhs Sixty four thousand Eight hundred and fifty only).

Now, I and my family members are taking shelter without at the parental house of my wife at Nambol Kongkham Makha Leikai under Nambol P.S. of Bishnupur District, Manipur. and nothing is left for my livelihood. I could of make this report in time due to suffering from mental trauma and stress.

I, therefore, request you to take up stern legal action against the Kuki miscreants and to book them according to law and also to recover the looted items from their possession at an early date.

This report is treated as an O.E of case


