The miscreants have ransacked and burnt down my RCC House and all properties like furnitures, Kitchen items, clothing, Barn, important documents, Grains and Rice, poultry and domesticated animals and other properties inside the house. The estimated value of properties lost, ransacked and burnt down by the miscreants is estimated to be about Rs. 1,00,00,000 (Rs. 1 Crore) only.

I, therefore request you to kindly take necessary action in this regard for which I shall remain ever thankful to you.
