- On 3rd May 2023 at approx 1800hrs Assam Rifles was requisitioned by the Govt of Manipur received Sir, through DC KPI for Aid to Civil Authority.
- On 28 May 2023 during night at approx 0015hrs onwards, while operating in aid to civil authority, own troops had to resort to firing in the Air to disperse unidentified personals/ANEs. The details of incidents are in succeeding paras.
- Firing incident took place in Singda Kuki. Firing commenced between Kuki Village of Geljang Village Defensive Force (VDF) volunteers, and Manipur Rifles located at SingdaKuki.Own columns fired upon by suspected UG Cadres / Miscreants. During the firefight two Lathods& automatic weapons were fired upon own columns. Own columns retaliated with controlled fire.
- IS (Internal Security) Duty columns of Assam Rifles was launched to contain the situation, due warning was given by own troops to disperse the crowd. Own columns warned them in vernacular, English &Hindi language and preventing them to move further. Sensing grave danger to life of innocent civilians &insurmountable threat to Govt property, controlled Fire was carried out by own columns as last resort to disperse the mob of unlawful assembly after adequate warning as legally mandated thereby, controlling the aggravating situation in time saving precious lives and preventing any collateral damage.
- Assam Rifles columns carried out search of the area after the controlled fire in air & dispersal of crowd to look for injured persons and provide medical aid & evacuation. There were no injured person at the location. No casualty of civilians reported.
- You are requested to kindly file an FIR against unknown armed rioters and investigate the incident for attempt to murder with deadly weapons, todeterpublicservantssuppressing riots, causing hurt with dangerous weapons and unlawful carriage of dangerous weapons and unauthorised usage of fire arms and ammunition to include automatic weapons.
