- On 13 May 2023 During the search operations carried out by 22 Assam Rifles at Sipijang. At 2. approx 1123hrs the column was fired upon by three to four unidentified individuals with arms and seven to eight rounds were fired towards own columns in jungle near Sipijang (West of Sapermeina). Own colimn retaliated with fire. The armed cadres dispersed and ran due to fire from own troops. No causality was reported .Search of the area and adjoining areas was carried out sung UAV & Tracker Dog and following recoveries were made:-
