Subject : Report.

Sir,

With due regards, I beg to state that today i.e. 06/03/2024 at about 05:20 am received a reliable information that some unknown miscreants have stored some arms, ammunitions and explosives in the jungle of Phouoibi village.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with COB Somrei, 33 AR 'D' COY led by Shri Okramcha Wangkhomba, MPS, Addl. SP(Ops)/TBL assisted by OC/CDO-TBL and OC/NSK-PS under the Supervision of Sr. SP/TBL have rushed to the spot immediately and launched a massive operation at 06:00 am by using metal detectors. On searching and found the undernoted articles i.e. (1) 01 (one) No. of 5.56 mm INSAS Rifle bearing registration No. 12CN3137 G-13 (2) 01 (one) No. of modified 2 inch Mortar, (3) 02 (two) Nos. of 36 HE Hand Grenade (can be used as explosive), (4) 01 (one) No. of Tube Launcher, (5) 01 (one) No. of WP GREN No. 80 MK-1, (6) 01 No. of Tear Smoke Grenade, (7) 02 (two) No. of Tear Smoke Shell Soft Nose, (8) 01(one) No. of Stun Shell Normal, (9) 01 (one) No. of Cartridge 38 mm Anti-Riot with Rubber Bullet, (10) 01 (one) No. of .303 LMG magazine & (11) 01(one) No. of modified mortar shell have been seized from the spot at 07:20 am. The massive searched Operation was conducted from 06:00 am and continue till 08:00 am of the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
