With due respect, I have the honour to report that on 4th May, 2023 at around 9 PM unknown Meitei miscreants suspected to be Arambai Tenggol holding deadly weapons entered our village and burnt down several houses of our village. Due to the fear of our lives being in danger, we fled from our village, leaving behind all our assets and home. Later, we learnt that our house was not burn but all our household properties was looted and vandalized. The total costs of the looted household properties are estimated to be approximately Rs. 13,00,000/(Rupees thirteen lakhs).

The incident could not be reported in time due to insecurity of our lives and the volatile situation of the area.

I, therefore, request you to take necessary action against the perpetrators/culprits involved in commission of the crime.
