I have the honour to state that on 4/5/2023 around 11:30am some unknown miscreants belonging to Meitei youth organization suspected to be member of ArambaiTenggolgroup. Meitei Leepun and KangleipakKanbaLup (KKL) world Meitei council and Schedule Tribe Demand Committee about 900-1000 members carrying sophiscated weapon like AK,Rifles, SLR. and 303 rifles with vehicles forcefully entered in my my house located at KangchupPatjang, PO-Lamsang.PS-GSPM, KPI. They looted all the valuable properties and burnt down the house. The approximate value of the lost property is 1 crore.

I therefore request your kind office to take further necessary action.
