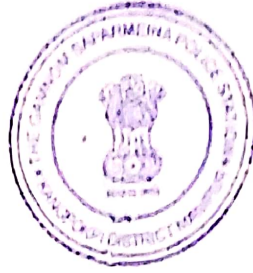

Meitei Leepun and KangleipakKanbaLup (KKL) world Meitei council and Schedule Tribe Demand Committee about 900-1000 members carrying sophiscated weapon like AK,Rifles, SLR. and 303 rifles with vehicles forcefully entered in my my house located at KangchupPatjang, PO-Lamsang.PS-GSPM, KPI . They looted all the valuable properties and burnt down the house . The approximate value of the lost property is 1 crore.

I therefore request your kind office to take further necessary action.
