

Sir,

I have the honour to report that, on 04/05/2023 at around 2:00 pm received a telephonic information from Leimakhong police station that my father namely Nganbam Yaima (70) S/o (L) Ng. Chaoba Singh of Khurkhul Makha Leikai was rescue with injury mark by their police team from KonsaKhul village area from the unruly kuki rioters while my father went to Konsa Khul for searching of our cow.

On received of the said information, on the same day at around 2:10 pm, I along with my uncle namely Ngangbam Ahongjao (72) S/O (L) Ng. Chaoba Singh of Khurkhul makha Leikai, my younger brother namely Ng. Amuba (42) S/o Ng. Yaima of Khurkhulmakha Leikai and my maternal uncle Sinam Nandakeshor (70) of Mayang Langjing have went to Leimakhong Police Out Post for pick up my father by driving two vehicles i.e one i10 car bearing Regd.No MN01AG - 8520 having Chassis no MALB55CLLM047220, Engine no. G4LAM543355 and one Astar car bearing Regd. No. MN02G - 1312, Chassis no MA3EPTE1S00281900 and Engine No. K10TEN1182153. While reaching at Leimakhong electricity gate, our vehicles were detained by the rioters suspected to be kuki youths numbering about 100/200 by holding deathly weapons like Knives, sticks, iron rods, weapons sharp object etc and started to assault us without giving any reason. As a result of which, all of us got seriously injured and our vehicles mentioned above also badly damaged. In the meantime our team was rescue by the police team As such, all of us including my father evacuated to hospital for medical treatment. Due to the medical treatment and the present situation in the state I couldn't report to the concern PS i.e Sapermeina-PS till date. Hence, I therefore reported to your good office for further procedure.

It is therefore, requesting you to kindly look into the matter and take up necessary action at the earliest.

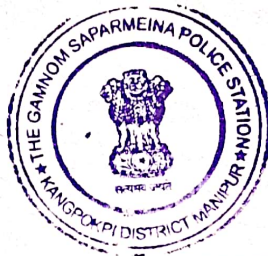




