Subject: Report on recovery of Arms and Ammunition

Sir,

On 19/8/2023 at around 1530 hrs, received a credible input about a cache of arms (looted and local made) in the foothills of Hengjang village, Leimakhong general area. By 1600hrs a joint team of LMK-PS (led by HC Th. James Khongmai) and IS column 20 Jat launched search operations in the area. During the operation the following weapons and ammunition were recovered.

1. 9mm carbine with magazine (Regd. No. 15316070) - 1
2. INSAS rifle with magazine (Regd. No. 18531365) - 1
3. Local made cannon (pompl) - 2
4. 9mm - 20 rds
5. 5.56 X 45 - 3 rds
6. Teargas cartridge soft shell - 3 rds

One local made clamour land mine (approx weighing 3 kg) was recovered and handed over to Indian Army teams for destruction.

I, therefore request you to kindly take up necessary legal action in this regard.
