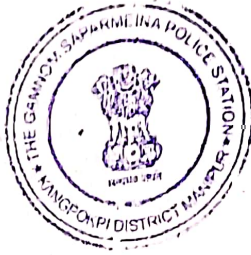

Therefore, I request your kind office to take legal necessary action.


