Dear Sir,

With reference to the above cited subject, I have the honour to report to you as follows:

1. That, I am a Scheduled tribes belonging to the Vaiphei Tribes, a recognized Scheduled tribes under the constitution of India. And, I am a permanent resident of Nakhujang Village PS Kangpokpi (GSPM-PS) District Kangpokpi, Manipur.
2. That, on the 2/6/2023 at about 5:PM AM/PM, a huge contingent of armed radical Meitei/Meetei, along with the Manipur State force like the Manipur Police Commando, the Indian Reserved Battalion (IRB) attacked our village and in the process they have looted, vandalised and torched my house.
3. That, it may be reported here that the miscreant were shouting slogan like "KANGLEIPAK YAIPHABA", "KUKI HATLO" "HAO HATLO", etc while they were carrying out their criminal activities.
4. That, it may also be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs.42,75,000/- (Rupees Forty two lakhs Seventy five thousand)only.

In the given circumstances, I humbly pray you to kindly register an FIR/ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country, And, for which act of kindness, I shall always remain thankful to you and obliged.
