





Sir, I have the honour to report you that on the intervening night of 3/5/2023 and 4/5/2023, the large numbers of Kukis with Knife and weapons came into my house and completely burn down as well as destroy my two houses and properties using fire, also looted much of properties, located below Charhajare ground.
