



Subject: Report

Sir,

I have the honour to state that, on dated 04/05/2023 at around 9:00 AM some unidentified groups suspected to be the members of Meitei Organisation such as Meitei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tengol numbering about 1500-2000 people and carrying sophisticated weapons forcefully entered our village i.e K. Patjang Village having around 25 houses under Saitu Sub-Division, Kangpokpi District Manipur.

In the incident, they have looted movable properties including domestic animals and cattle's, vandalised and burnt down my house. The approximate value of looted, destroyed and burnt down properties are estimated at about Rs.20,00,000/- (Rupees Twenty Lakhs).

So, I therefore requested you to kindly register this case and take the necessary legal action against the culprits according to the law.


