Sir,

With due respect and humble submission, I beg to state that on 4/05/2023 at around 12:00 PM, some unknown armed miscreants suspected to be meeitei Youth organization Arambai Tenggol, Meeitei Leepun and Kangleipak Kanba Lup (KKL) numbering about 1000 carrying sophisticated weapons like AK Rifles, SLR forcefully entered my village Kangchup Patjang village, P.O. Lamshang, P.S- Gamnom Sapormeina, Kangchup Geljang Sub-Division, Kangpokpi District, Manipur. After looting all the valuable house hold items and properties, my house and all my sister's (Lhingkhonei Gangte) educational certificates were burnt down to ashes living homeless, apart from that some important parts of my house i.e kitchen Set with utensil Almera (6) sofaset (2), computer (2) refrigerator (1) MI-TV 53 cm, washing machine, inverter, gold ear ring, blanket (30) metress (10), gas stove (5) cylinder (3) dining table 2 set, chair (10) sintex (5) motor big size (2) and some utensils were totally burnt down.

The approximate value of loss properties is estimated at about rupees 70,00,000/- (Rupees seventy lakhs).


It is therefore, I requested to kindly register the case and take necessary action according to law.
