With due respect, I have the honour to report the following few lines that, I have staying at a rented house of one Hatnu (owner) at Leimakhong Bazar Kangpokpi District since last 10 Years back. Also running a vegetable shop at the said rented house. Due to the ongoing communal crisis between two communities, on 2/05/2023 at around 4:30 pm, I have come out from the said rented house and taking shelter at my aunty house located at Leikhinhabhi Shantipur, IW district by keeping my under locked and key. On 04/08/2023 at 2:30 Pm, it comes to light that, suspected to be the Kuki arms militant and Kuki rioters had trespass the said rented house and looted my belongings properties i.e furniture, kitchen, utensils, clothing & electronics items and others by breaking the lock and key which I had locked. The approximate value of the properties is Rs. 15,00,000/- ( fifteen Lakh).

Regarding the matters I couldn't able to report till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is therefore requested you kindly look into the matter and take up necessary action at the earliest.


