



Sir,

With due respect, I have the honour to report the following few lines that on 3rd May 2023 at around 7:00 pm, some unknown persons suspected to be Kuki militants opened fire towards Meitei populace area of Leimakhong Bazar and vandalised and looted many houses of Meitei.

In that, the kuki armed militants had trespass my rented house as well as sewing shop, (Patung – house owner) and all the household properties like furniture items, utensils items, Kitchen items, clothing, electronic items, 10 Sewing machine and others were looted as well as vandalised my house by the militants. The approximate value of burnt down/looted properties are estimated at ₹.30,00000/- (Thirty lakh only) approximately.

Regarding the matters I couldn't be able to report to the concern Police Station i.e. Gamnom Sapormeina PS till date due to the present situation in the state. Hence I therefor reported to your good office for further procedure.

It is therefore requested that you to kindly look into the matter and take up necessary action at the earliest


