Sir,

With due respect, I have the honour to report the following few lines that, I am resided at a rented house located at Leimakhong Bazar, KPI district which is under the control of Kuki arms militants since the beginning of the current communal riots. Due to the ongoing communal crisis between two communities, on 4/05/2023 at around 5:00 am, I along with my family members have come out from my residence and taking shelter at Kanto Awang Leikai relief camp, IW by keeping my rented house and Tiles & sanitary shop under locked and key. On 13/08/2023, it comes to light that, suspected Kuki arms militant Kuki rioters had trespass my house and Tiles & Sanitary shop and looted/Vandalized my properties i.e furniture, kitchen, utensils, clothing & electronics items, Cash ( Rs 50,000/-, jewelry and shop items and others by breaking the lock and key which I had locked. The approximate value of the properties is Rs.50,26,000/- ( Rs Fifty Lakh & twenty six thousand).

Regarding the matters I couldn't be able to report to the concern PS i.e. Gannom Sapormeina PS till date due to the present situation in the state. Hence I therefore reported to your good office for further procedure.

It is therefore requested that you kindly look into the matter and take up necessary action at the earliest


