

Sir,

With due respect, I have the honour to report the following few lines that, I am resided at a rented house owned by one Heikham Nandakumar Singh since last 9 years back located at Leimakhong Bazar Board near Durga Mandir, KPI district which is under the control of Kuki arms militants since the beginning of the current ethnic violence i.e 3rd May 2023. Due to the ongoing communal crisis between two communities, on 4/05/2023 at around 11:00 am, I along with my family members have come out from my residence and taking shelter at Lamphel Sanakeithel by keeping my rented house under locked and key. However, on 20/08/2023, it comes to light that, some unknown persons suspected to Kuki arms militant holding sophisticated weapons had trespass my rented house and looted/Vandalized many properties i.e furniture, kitchen, utensils, clothing & electronics items, Cash (i.e Rs 2,50,000/- which were kept inside the iron godrej), Gold approximate value Rs 3,50,000/- and others by breaking the lock and key which I had locked. The approximate value of the properties that were Vandalized & looted is about Rs.10,00,000/- (Rs Ten Lakh).

Regarding the matters I couldn't be able to report to the concern PS i.e. Gamnom Sapormeina PS till date due to the present situation in the state. Hence I therefore reported to your good office for further procedure.

It is therefore requested that you kindly look into the matter and take up necessary action at the earliest


