

Sir,

With due respect, I have the honour to report the following few lines that, I am resided at a rented house owned by one Helan Singh since last 7 years back located at Leimakhong Bazar Board near opposite to KV school, KPI district which is under the control of Kuki arms militants since the beginning of the current ethnic violence i.e 3<sup>rd</sup> May 2023. Due to the ongoing communal crisis between two communities, on 4/05/2023, I along with my whole family had fled away from my rented house due to fear & safe of our life and taking shelter at Kanto Awang Leikai relief camp.

However, on 21<sup>st</sup> August 2023, it comes to light that, some unknown persons suspected to be Kuki militants holding sophisticated weapons had trespass my rented house cum grocery shop in between 4th may 2023 to 21<sup>st</sup> August 2023 and looted many valuable properties from my rented house & grocery shop i.e all the goods/items of grocery shop, electronic items, kitchen items, utensils items, clothing, furniture items, 2 gas cylinder, Gold (approx. value Rs 1,44,000/-), Cash(Rs 50,000) & others. The approximate value of the properties that were looted is about Rs 15,00,000/ (fifteen lakh).

Regarding the matters I couldn't be able to report timely to the concern Police Station i.e. Gannom Sapormeina Police Station due to the present ethnic communal violence in the state.

It is therefore requested you to kindly take up necessary legal action.


