3. Tea Hotel worth Rs. 5 lakhs
4. Household Items worth Rs. 8 lakhs
5. Washroom worth Rs. 1.5 lakhs
6. Approximate value of one house is Rs. 27.5 lakhs
7. Miscellaneous Household Items worth Rs. 8 lakhs

Total approximate value of property lost during arson, loot and destruction was Rs. 35.5 Lakhs (thirty five lakhs and fifty thousand)
