



3. Washroom worth Rs. 3 lakhs
4. Household items worth Rs. 8 lakhs
5. Piggery worth Rs. 2 lakh
6. Approximate value of one house is Rs. 27 lakhs
7. Miscellaneous Household Items worth Rs. 8 lakhs

Total approximate value of property lost during arson, loot and destruction was Rs. 35 Lakhs (Thirty Five lakhs only)


