- 4. That Delay of filing a F.I.R. is due to displacement and uncertainty of relief/place.

In view of the facts and circumstances, I shall be very grateful if your goodself would kindly initiate appropriate steps for identifying the unknown arms miscreants: apprehend them and punish them in accordance with law.
