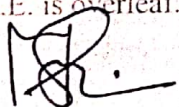

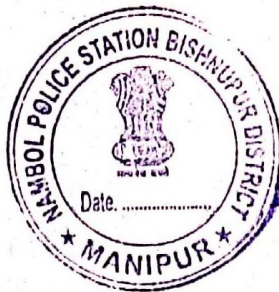

Today i.e. 21/01/2024 at 9:15 pm received a reliable information that on the same day at around 9:10 pm, one Maruti Alto car bearing regd. No. MN05A-7513 driven by one unknown driver which was proceeding from Imphal side towards Nambol side collided with one Honda Activa bearing regd. No. MN01AM-0298 ridden by one unknown rider which was proceeding from the opposite direction at Kodompokpi Lamkhai along Tiddim road due to rash and negligent driving on the part of unknown driver of Alto car and the rider of Honda Activa. As a result of which, the unknown rider and two pillion riders of Honda Activa received injury on their persons and evacuated to hospital for medical treatment. The involved Honda Activa was badly damaged and Alto car was also partly damaged.

Hence, a regular case under FIR No. 05(01)2024 NBL-PS U/S 279/338/427 IPC is registered on suo moto for investigation.
