Sir.

I have the honour to report that yesterday, the 31 January, 2023 from 9:00 A.M. to 4:00 P.M. a joint team of Kangpokpi District Police led by OC/KCP-PS, Kangpokpi Forest led by Range Forest Officer, Motbung Range, under the supervision of SP/Kangpokpi and DFO/Kangpokpi conducted destruction of illicit Poppy plants inside Kangchup Reserve Forest near Kangchup to Tamenglong Road about 7 kms from Kangchup Police Station under the jurisdiction of Kangchup Police Station in which illegal Poppy plantation of approximately 12 acres which were planted by breaking of land prohibited in the reserved forest land were completely destroyed. Since, it was very late by the time we returned from destruction duty yesterday, I am to submit the report to your office today.

Poppy plants/pods which were collected from the destroyed poppy cultivation site have also been submitted as evidence.
