**Sub:- Filing of FIR against suspected underground Cadres/Miscreants**

Sir,

1. Internal Security Duty column of Assam Rifles were deployed in the general area Kangchup for protection of civilians and maintaining peace in terms of the requisition by the Govt. of Manipur on 02 September 23 at around 0500 hrs intermittent firing commenced from Chingkhong towards Songlung village and Geljang Village. AR columns deployed in the area observed 08-10 rioter/Miscreants in Police uniforms who sneaked through Singda forest and reached Geljang Village and burnt two sheds there at around 0530 hrs. Own columns after confirming from Police authorities (SP-KPI) that the individual in Police uniform are not from Police. challenged them. On being challenged the armed rioters/miscreants fired indiscriminately towards own columns. Also another AR column which had reached Songlung was fired upon from near hill top. Own columns in both locations retaliated in a calibrated manner with controlled fire. in self defence and for protection of civilians in the area. Firing stopped at 0630 hrs and no casualties or collateral damage has been reported.
2. After firing had stopped at 0630 hrs. Columns carried out search of the area. The following items used by the armed rioters. Miscreants were recovered:-
  - (a) 13 rounds – Latode Fired Cases (40 mm).
  - (b) 11 rounds – 7.62 x 39 mm Fired Cases
  - (c) 06 rounds – 7.62 mm x 51 mm Fired cases.
  - (d) 43 rounds – 5.56 mm Fired cases.
  - (e) 06 rounds - .300 Fired Cases.
3. You are requested to kindly file an FIR against unknown armed rioters/miscreants and investigate for attempt to murder with deadly weapons, arson, to deter public servants suppressing riots, cause hurt with dangerous weapons and unauthorized usage of the fire arms and ammunition to include automatic weapons.
