I the undersigned the Centre Manager, Kangchup Geljang Block Kangpokpi District- CRISIL FOUNDATION Manipur and its Office located at the Homestead land of Shri Onkholun Haokip of Kangchup Songlung Village, Kangpokpi District would like to report to your good office that on the fretful day i.e., the 2nd June 2023(Friday) around 11:30 a.m. thousands Meitei Mob led by the Arambai Tenggol & Meitei Leepun under the guidance of the people/villagers of Phayeng, Imphal West District were attacking Kangchup Songlung village Kangpokpi District by using sophisticated weapons & bombs, shells etc. and when they dispersed the local people and as we (the villagers) were running for our life and safety. The intruders (the attacker) had robbed and vandalised our houses, shops, establishments and burnt down all the houses/shops of Kangchup Songlung Village including the above mentioned office.
