

1. Furniture : Wooden Almirah 4 doors, Godrej 1, Wooden long Arm Bench –set 1, Bed 3, Bed Box-1, Dining set, Wooden Drawer- **worth : Rs 2,30,000/-**
2. Electrical appliances : Refrigerator, Washing Machine, Induction, Smart TV, Iron, Kettle. **Worth : Rs45,000/-**
3. Kitchen ware including 3 cylinder **Worth : Rs40,000/-**
4. Traditional Shawl, Wrapper, Necklace Gold Earring -2
Gold ring 1 san **Worth : Rs1,07,000/-**
5. Granary (60 bags) **1900 x 60 Paddy bags** **Worth : Rs1,14,000/-**
6. Approximate value of One House in Rupees **Rs 20,00,000/-**
