worth : Rs 2,00,000/-
2. Electrical appliances : Refrigerator, Washing Machine, Induction, Smart TV,
Iron Kettle Worth : Rs 45,000/-
3. Kitchen ware including 2 cylinder Worth : Rs 35,000/-
4. Traditional Shawl, Wrapper, Necklace, Gold Earring 2san, Worth : Rs 92,000/-
5. Granary (47 bags) 1900 x 47 Paddy bags Worth : Rs 89,000/-
6. Approximate value of One House in Rupees Rs 17,00,000/-
7. Miscellaneous household items Worth : Rs 80,000/-
8. Cash Rs 60,000/- Approximate

I thus hereby request you to kindly register this complaint as FIR.


