With due and humble submission, I beg to state that on 05/05/23 at around 12:00 Pm some unknown miscreants armed youth suspected to be people Liberation army (PLA)United national liberation front(UNLF) Kanglei Yaowon Kanna Lup (KYKL) and prepak cadres assisted by Meitei youth organization Arambai Tengol Meitei leepun and kangleipak kanba lup (KKL)numbering about 1000 member carrying sophisticated like AK Rifle. SLR forcefully entered my village Singda Kuki village, P.O. Lamshang, P.S. Gamnom Sapormeina, Saitu Gamphazol sub-Division, Kangpokpi district Manipur. After looting all the valuable house hold items and properties my house was burnt down to ashes.

The total worth of properties lost are as follows:

- (i)Residential house (Rs 5,00,000)
- (ii) House on construction (Rs11,00,000)
- (iii) Kitchen (Rs 1,50,000)
- (iv) Bed and two Almirah (1,00,000)
- (v) Carpenter equipments (Rs 1,00,000)
- (vi) Furniture (Rs 4,00,000)
- (vii) Utensils (Rs 1,50,000)
- (viii)Traditional shawl and cloths (Rs 2,00,000)
- (ix) Rice barn (Rs 1,50,000)

The approximate value of lost properties is estimated at about rupees 30,00,000/-

(Thirty lakhs only)

Therefore, I request you to kindly register the case and take necessary action according to law.
