

Sir,

With due respect and humble submission, I beg to state that on 05/05/23 at around 12:00 Pm some unknown miscreants armed youth suspected to be people Liberation army (PLA) United national liberation front(UNLF) Kanglei Yaowon kannu Lup(KYKL) and prepak cadres assisted by Meitei youth organization Arambai Tengol Meeitei leepun and kangleipak kanba lup (KKL) numbering about 1000 member carrying sophisticated like AK Rifle, SLR forcefully entered my village Singda Kuki village, P.O. Lamshang, P.S.Gamnom Sapormeina, Saitu Gamphazol sub Division, Kangpokpi district Manipur. After looting all the valuable house hold items and properties my house was burnt down to ashes.

The total worth of properties lost are as follows:

- (i) Bed - 4 (Rs 1,20,000)
- (ii) Almirah (Rs 14,00,000)
- (iii) Dressing table (Rs 25,000)
- (iv) Fridge (20,000)
- (v) Television (Rs 30,000)
- (vi) Gas box including Gas stove and two Cylinders (Rs 50,000)
- (vii) Mattress (Rs 20,000)
- (viii) Sofa set (1,00,000)
- (ix) Dining Table (Rs 25,000)
- (x) Kitchen set (Rs 65,000)
- (xi) Estimate cost of residential house (Rs.15,00,000)

The approximate value of lost properties is estimated at about rupees 35,00,000/-
(Thirty five lakhs only)

Therefore, I request you to kindly register the case and take necessary action according to law.
