With due respect, I have the honor to report that, on 05-05-2023 at around 10:00 am, groups of miscreants suspected to be Arambai Tengol, Meitei Leepun and other extremist volunteers numbering more than 500 people by firing various automatic weapons attacked our village i.e Singda kuki village, Kangchup, Kangpokpi District. In the incident, the miscreants have vandalized my pucca house, looted my household properties and domestic animals and finally burn down my pucca building and destroy the remaining pillar, slap, wall by using JCB.

The approximate value of the loss properties is estimated to be about 80 lakhs ( Eighty lakhs) only.

I therefore kindly request you to take necessary action in this regard.


