In the incident, the miscreants have vandalized my pucca house, looted my household properties and domestic animals and finally burn down my pucca building and destroy the remaining pillar, slap, wall by using JCB.

The approximate value of the loss properties is estimated to be about 80 lakhs (Eighty lakhs) only.
